



Transfer of Ownership / Gift-In-Kind Donation

I/We, **[Donor Name(s)]**, am/are pleased to support San Diego State University. I/We certify that I/we am/are the owner(s) of the property described below and wish to transfer said property as a gift to The Campanile Foundation (TCF) to further the core mission and priorities of the University.

In accordance with the terms set forth herein, I/we donate these materials unconditionally, and irrevocably transfer any and all rights, title and interest, which I/we now have or may possess in the future to the below described property, to TCF.

I/We understand that this is an unrestricted gift to be held or sold at the sole discretion of the University. I/We understand that the items described herein are to be used by the University to continue to provide research-oriented, high-quality education for undergraduate and graduate students, and to contribute to the solution of problems through excellence and distinction in teaching, research, and service, limited by University's policies and procedures. I/We agree that the University reserves the sole right to determine retention, location, cataloging, preservation, and other considerations relating to the gift's use or disposition, in accordance with its policies and procedures. As such, while it may be the University's intention to accept these objects for long-term use and preservation, no guarantee shall be made that the gift will be retained in perpetuity, that it will be displayed/utilized at all times, or that it will be displayed/utilized in a certain manner, or that it will be displayed/utilized at all

I/We understand in order to claim a deduction of more than \$5,000 per item (or a group of similar items), I/We have included a qualified appraisal of the item or group of items and completed, signed IRS Form 8283, Section B. Appraisals must be secured by the donor at their own expense.

I/We understand that if a cash gift or endowment does not accompany these materials, the materials may not be available for use or exhibition until funds become available for cataloging and processing, and that preservation may also be reliant on funds from the department's limited budget.

The Campanile Foundation reserves the right to decline any gift that is inconsistent with the University's goals or requires special maintenance or conditions that the University cannot meet within its resources. Gift acceptance is contingent upon approval by the appropriate university official and items cannot be accepted until approval is received. These terms apply to all gifts of goods, services and tangible property. The only University officers who can accept modifications to a gift-in-kind agreement is the Foundation President and CEO for materials valued up to \$100,000 and the SDSU President for materials over \$100,000.
